General Information

Crating will be indoors. Please remember to keep all grooming to a minimum per UKC rules. Those caught not disposing of debris in proper containers will be asked to leave. Building will be open to exhibitors at 2:30 pm on Friday; 6:00 am on Saturday/Sunday. Overnight security is not provided and no dog(s) may be left in the building overnight. All times are Pacific unless stated otherwise. There will be absolutely NO SMOKING in all buildings. No admission or parking fees. Dogs must be permanently registered with UKC, have a Temporary Listing (TL) number, or have a Limited Privilege (LP) listing number by the closing date and time in order to enter. No exceptions will be made. Entries for ineligible dogs will be returned. An unentered dog may not be substituted for an entered dog. Entries may be submitted on the Official UKC Entry Form included with this premium or on any current official UKC entry form. Downloaded copies or photocopies of these forms may be used as well, but must have both front and back of entry form. Pre-entries may be mailed, or sent on-line to Susan Mulligan. Entries received after the pre-entry closing time will be accepted, but will be charged the day-of-show entry fee. Mailed entries must include entire entry form, fees and must be signed. No refund of entry fees will be made for entries canceled after the pre-entry deadline, except in the case as of a bitch that comes into season and is entered in obedience, agility or Terrier races. In those cases, refunds may be obtained by providing UKC with a veterinarian's certificate verifying that the bitch came into season after the closing date. The certificate may be mailed provided the postmark is no later than the date prior to the day of the trial, or delivered by hand to the trial secretary before the start of the trials. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Vet or Judge, or barred from competition by action of Event Committee. If, because of riots, civil disturbances, or other acts beyond the control of the host organization it is impossible to open or to complete a show or trial, no refund of entry fee will be made. No refund on duplicate entries if not found before processing. If, in the opinion of the host club, the well-being of dogs, exhibitors or spectators is at risk due to weather conditions the host club may cancel or stop a show before completion with no refunds.

ENTRY CONFIRMATION

Written confirmation of entries will be made by mail as soon as practicable after receipt of pre-entries. If you do not receive your confirmation by the Saturday preceding these events, please notify UKC (PSK-9's for non-licensed). Receipt of on-line entries will be acknowledged immediately by return e-mail, but this does not constitute confirmation of the entry.

CLASS CHANGE/CORRECTION OF ENTRY

Owners are responsible for the accuracy of information on the entry forms, regardless of who may make such errors. Owners and exhibitors are responsible for correcting any errors in their entry.

Dogs that, according to their owners' records, have completed the requirements for a title after the closing of entries, may be transferred from the entered class to another class for which the dog is now eligible, provided that a request for transfer is made in writing to UKC not later than one-half hour prior to the start of any regular judging at the show.

All other corrections to entries must be made in writing to UKC not later than one-half hour prior to the start of any regular judging at the show.

ARMBANDS

One armband will be assigned to each entered dog for all shows and trials in which the dog is entered for the weekend. Armbands will be mailed with the entry confirmations. If you do not receive your armband prior to the start of judging on July 4, please come to the Superintendent's table for a replacement.

SCHEDULING CONFLICTS - DOGS COMPETING IN MULTI EVENTS

Exhibitors are responsible for being available for judging at the scheduled time. Every possible effort will be made to accommodate exhibitors who have dogs entered in multiple events, but judges are not required to wait for dogs. Exhibitors are advised to pick up their armbands as early as possible and to notify stewards in all rings affected by the conflict so that judges may more easily work around any conflicts. If an obedience/agility exhibitor misses a scheduled judging time, the judge has the discretion to allow that exhibitor to show at the end of the class.

DIRECTIONS TO SHOW SITE

Take I-5, I-405, SR-167 to Highway 18 eastbound. Exit onto Auburn-Black Diamond Road eastbound. Turn right onto SE Green Valley Road (just past neely Mansion). Follow for about 7.5 miles. Turn right onto 212th Way SE (right after green bridge sitting on land at right). Take first left into Argus Ranch and follow drive to parking. Main arena is on your right, first building on left is the Brutus Hall, building straight ahead is the agility arena and 2nd building to the left is the obedience building. Terrier races are to the right past the main conformation bldg, where the shelter building is located. Sign is at beginning of driveway for assigned RV parking.
