- Entry forms: PUGET SOUND K-9'S reserves the right to refuse incomplete or incorrectly filled-out entries, or entries with insufficient funds.

- Note: Temporary Listing (TL) Numbers must be assigned before or on the show date. TL Numbers that are issued after the event will be considered invalid
- Crating Space: Please note that there will be no indoor crating space available for the Rally Obedience trial on Sunday.
- Jump Heights: Please remember to include the dog's height at the shoulders for obedience (all class levels) or jump height division for Rally.
- Bitches in season may not compete.
- No refund of entry fees will be made for entries cancelled after the PE Entry deadline, except in the cases of bitches that come into season. In those cases, refunds may be obtained by providing the trial secretary with a veterinarian's certificate verifying that the bitch came into season after the closing date. The certificate may be mailed, provided the postmark is no later than the date prior to the day of the trial, or delivered by hand to the Event Secretary before the start of the trials.
- Move-ups: Exhibitors may move up to the next class or section for the next trial after finishing a title. Move-ups must be presented to the Trial Secretary prior to the beginning of the class.
- Liability: Neither PUGET SOUND K-9'S nor the United Kennel Club, Inc. is responsible for theft, loss, accident, or injury to any dog, person, or property at any of its events.
