#### **ELIGIBILITY**

All UKC Nosework Rules will apply to this trial. Dogs must be permanently registered with UKC or have a Temporary Listing (TL) or Limited Privilege (LP) number in order to enter. Nosework events are open to all UKC registered breeds and mixed-breed dogs

#### VOLUNTEERS

Please support our efforts by volunteering to work. It takes the help of many to ensure everyone has the opportunity to compete with their dog and to help ensure a trial runs smoothly. Workers are always welcomed, needed, and most of all, appreciated. To run this trial, our club of 15 members is counting on the help of volunteers to fill all the positions needed to keep the trial flowing. Nothing is really hard to do and we will gladly work with you on what works best for you and put out a schedule ahead of time. Show Chair, J'Anna Lyttle, will e-mail you when you check the volunteer box. Thanks in advance for helping us to provide another outlet for what we all enjoy doing with our dogs.

#### SECTION A or SECTION B

When entering UKC Nosework trials, please note the boxes requiring participant to indicate whether he or she is entering Section A or Section B. Ribbons will be awarded separately for each section.

**Section A**. This section is for true beginners of the sport. This section is open to all exhibitors and dogs that have not earned a title in the element in which they are entering or equivalent title in another organization. The exhibitor must own the dog entered or be a member of the owner's household or immediate family. Once the dog has earned the title they may no longer compete in the "A" section. No licensed or professional dog trainer or Nosework instructor, regardless of the person's status as an amateur or professional, may compete in this section. No person licensed to officiate Nosework in UKC or any other organization may compete in this section.

**Section B**. Any dog or handler that is qualified is eligible to compete in Section B. Dog and handler teams may continue to compete in this section indefinitely. The exhibitor does not need to own the dog entered.

#### REFUND POLICY

A 100% refund will be given for any requests for withdrawals received prior to the closing date. There will be no refunds after closing date.

#### CLASS AWARDS

Ribbons will be awarded for each Qualifying Search (including Pre-Trial). Ribbons awarded for 1st through 4th placements in Element Searches, New Titles, Highest Scoring UKC-registered Junior Handler and High in Trial

#### MOVE UP POLICY

Move Ups will be allowed if the Trial Secretary is notified prior to the closing date. No Move Ups will be allowed at the trial. A Class Change/Entry Correction Form (available on the UKC website or from the Trial Secretary) must be completed in full. Per the rules, "Owners who move their dogs to the next level of competition prior to being notified by UKC that their dog has met the title requirement to do so at their own risk. If the owner's records are incorrect, all passing searches and points earned while competing at the higher level of competition shall be disallowed."

#### **PHOTOGRAPHY**

There will not be an official photographer at this trial. It is within UKC Nosework rules to have up to two non-entered persons accompany you to the search area to take still photos and/or video your runs, at the discretion of the judge. If it is deemed the search area does not accommodate this number of people, for whatever reason, that search area will be off limits to accompanying persons. Should a dog become distracted by the accompanying person(s), there will be no re-run of the element. Be especially careful when you have a video or pictures of a search that they are not seen or talked about until the end of the trial!

#### REACTIVE DOGS

UKC does not recognize red bandanas for reactive dogs. There will be no reactive dog parking area or potty area. Each person is responsible for keeping a comfortable distance between their dog and other dogs at all times. Dogs must be on a six foot leash, in a crate, or in the car at all times except when searching, where longer leads or off leash where judge permits will be allowed. It is the responsibility of each dog handler to manage their own dogs. We all want the trial environment to be safe and comfortable for all the dogs and people entered and watching. Please read the rules regarding reactive dogs before entering.

#### **Driving Directions to Frontier Park:**

From the North, take Hwy 167 to West Hwy 512. Exit at the top of the hill after you see the Washington State Fairgrounds. The signs say, "South Hill/Eatonville/WA 161." At the top of the exit, turn right onto 31st Street E., then left at the next light onto 94th Ave. E/9th St. SW. Follow 94th Ave to 144th Street then turn left. Follow 144th Ave to Meridian and turn right onto Meridian. Continue on Meridian until you get to Frontier Park, which will be on your right.

**From the West and South**, take I-5 to Hwy 512. Take the first exit after Canyon Road. Again, it says "South Hill/Eatonville." At the top of the exit, turn right onto 94th Ave. E./9th St. SW. Follow 94th Ave to 144th Street then turn left. Follow 144th Ave to Meridian and turn right onto Meridian. Continue on Meridian until you get to Frontier Park, which will be on your right.
