ELIGIBILITY

All UKC Nosework Rules will apply to this trial. Dogs must be permanently registered with UKC or have a Temporary Listing (TL) or Limited Privilege (LP) number in order to enter. Nosework events are open to all UKC registered breeds and mixed-breed dogs

VOLUNTEERS

Please support our efforts by volunteering to work. It takes the help of many to ensure everyone has the opportunity to compete with their dog and to help ensure a trial runs smoothly. Workers are always welcomed, needed, and most lof all, appreciated. To run this trial, our club of 15 members is counting on the help of volunteers to fill all the positions needed to keep the trial flowing. Nothing is really hard to do and we will gladly work with you on what works best for you and show you how to do it if needed. Thanks in advance for helping us to provide another outlet for what we all enjoy doing with our dogs.

SECTION A or SECTION B

When entering UKC Nosework trials, please note the boxes requiring participant to indicate whether he or she is entering Section A or Section B. Ribbons will be awarded separately for each section.

Section A. This section is for true beginners of the sport. This section is open to all exhibitors and dogs that have not earned a title in the element in which they are entering or equivalent title in another organization. The exhibitor must own the dog entered or be a member of the owner's household or immediate family. Once the dog has earned the title they may no longer compete in the "A" section. No licensed or professional dog trainer or Nosework instructor, regardless of the person's status as an amateur or professional, may compete in this section. No person licensed to officiate Nosework in UKC or any other organization may compete in this section.

Section B. Any dog or handler that is qualified is eligible to compete in Section B. Dog and handler teams may continue to compete in this section indefinitely. The exhibitor does not need to own the dog entered.

REFUND POLICY

A 100% refund will be given for any requests for withdrawals received prior to the closing date. There will be no refunds after closing date. Because of the COVID-19 pandemic, the Puget Sound K-9's are not assured that we can hold this event. While we would prefer that the event go on, the health and welfare of our judges, members, and exhibitors is paramount. If we do have to cancel, we will refund all entry fees. If we are able to hold the event, we will send the necessary safety requirements to all exhibitors with the run order. These requirements will be based on current state and local requirements and the Center for Disease Control.

CLASS AWARDS

Ribbons will be awarded for each Qualifying Search. Ribbons awarded for 1st through 4th placements in Element Searches, New Titles, Highest Scoring UKC-registered Junior Handler and High in Trial.

SUBSTITUTION POLICY

If an entered dog must be excused (due to female in season or medical or other issue as noted in the UKC Nosework Rule Book) the exhibitor may enter another dog registered with UKC to themselves or an immediate family member. Exhibitor must complete both a UKC Nosework Entry Form for the new dog plus a Class Change/Entry Correction Form (both available from the UKC website or from the Trial Secretary) before the closing date. No substitutions will be allowed at the trial. If the entered handler cannot participate in the trial, another person may handle the UKC registered/entered dog.

PHOTOGRAPHY

There will not be an official photographer at this trial. Although it is within UKC Nosework rules to have up to two non-entered persons accompany you to the search area to take still photos and/or video your runs, due to COVID restrictions we anticipate that attendance will be limited to entered dogs and handlers only.

REACTIVE DOGS

UKC does not recognize red bandanas for reactive dogs. There will be no reactive dog parking area or potty area. Each person is responsible for keeping a comfortable distance between their dog and other dogs at all times. Dogs must be on a six foot leash, in a crate, or in the car at all times except when searching, where longer leads or off leash will be allowed where judge permits. It is the responsibility of each dog handler to manage their own dogs. We all want the trial environment to be safe and comfortable for all the dogs and people entered and watching. Please read the rules regarding reactive dogs before entering.

VEHICLES – WE NEED HELP

Because we are a small club, we do not have enough vehicles available from club members for vehicle searches both days. For us to be able to use your vehicle, you will need to keep it odor free for one month before the trial. We will have space available for your crate & dog while your vehicle is used in the search.

We need five vehicles total for the weekend. Your consideration is appreciated.

Driving Directions to Frontier Park:

From the North, take Hwy 167 to West Hwy 512. Exit at the top of the hill after you see the Washington State Fairgrounds. The signs say, "South Hill/Eatonville/WA 161." At the top of the exit, turn right onto 31st Street E., then left at the next light onto 94th Ave. E/9th St. SW. Follow 94th Ave to 144th Street then turn left. Follow 144th Ave to Meridian and turn right onto Meridian. Continue on Meridian until you get to Frontier Park, which will be on your right.

From the West and South, take I-5 to Hwy 512. Take the first exit after Canyon Road. Again, it says "South Hill/Eatonville." At the top of the exit, turn right onto 94th Ave. E./9th St. SW. Follow 94th Ave to 144th Street then turn left. Follow 144th Ave to Meridian and turn right onto Meridian. Continue on Meridian until you get to Frontier Park, which will be on your right.


