Day-of-Trial: DOS entry \$28. Non-licensed Classes: \$12

Jr. Handler PE and Day of Show: \$12

Obedience entry is limited to 55 entries judged each day.

Rally entry is limited to 125 entries judged each day.

Day of trial entries will be accepted according to the following schedule if a trial has not filled:

Obedience Entries: Saturday September 23, 7:30-8:30 a.m.

Saturday Novice and NLC: 10-10:30 a.m.

Obedience Class Judging: Utility & Open judging begins 9:00 a.m.

Novice judging begins: No sooner than 10:30 a.m.

Food & Beverages

PSK-9s will provide beverages and a light lunch to judges, club members, and workers. All others may partake with a suggested donation of \$5.

Show Policies:

- **Entry forms:** PUGET SOUND K-9'S reserves the right to refuse incomplete or incorrectly filled-out entries, or entries with insufficient funds.
- **Entry fees:** If you are not sure about the entry fee amount, please ask ahead of time, or send the greater amount, and the club will refund any overage. We thank you for reducing the number of long-distance phone calls the secretary must make by ensuring your entry is accurate and complete, and emailing inquiries whenever possible.
- **Registration No.:** U.K.C. rules prohibit the acceptance of entries with "pending" or missing registration numbers. Temporary registration (TL) numbers must be purchased prior to the show via the UKC website – www.ukcdogs.com; select the Show tab, then select the TL Numbers.
- *Note: Temporary Listing (TL) Numbers must be assigned before or on the show date. TL Numbers that are issued after the event will be considered invalid.*
- **Crating Space:** Indoor crating space is available in the arena.
- **Jump Heights:** Please remember to include the dog's height at the shoulders for obedience (all class levels) or jump height division for Rally.
- **Bitches in season may not compete.**
- No refund of entry fees will be made for entries cancelled after the PE Entry deadline, except in the cases of bitches that come into season. In those cases, refunds may be obtained by providing the trial secretary with a veterinarian's certificate verifying that the bitch came into season after the closing date. The certificate may be mailed, provided the postmark is no later than the date prior to the day of the trial, or delivered by hand to the Event Secretary before the start of the trials.
- **Move-ups:** Exhibitors may move up to the next class or section for the next trial after finishing a title. Move-ups must be presented to the Trial Secretary prior to the beginning of the class.
- **Liability:** Neither PUGET SOUND K-9'S nor the United Kennel Club, Inc. is responsible for theft, loss, accident, or injury to any dog, person, or property at any of its events. Absolutely no alcoholic beverages or drugs are allowed. Aggressive behavior by dogs shall not be tolerated at U.K.C. events.
- **Entry times, Fees, and Run-Orders:** While every attempt is made to provide accurate information in this premium, the event data as listed on the UKC event page takes precedence.

- Mail all completed entry forms to the Event Secretary listed under the event, unless otherwise specified. Make checks payable to host club.
- All UKC performance events are open to any UKC registered dogs and dogs with a valid Performance Listing/Limited Privilege number, with the exception of Lure Coursing and Drag Racing. Please see the rules for each event regarding eligibility.
- We want you to keep the points earned at UKC Licensed events.**
Important things to remember:
 - Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at www.ukcdogs.com or call the Dog Events Department at (269) 343-9020. (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
 - All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Performance Listing/ Limited Privilege number.**
 - All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.
